Section 4 - First Aid Measures

General Information:

Self Injection: Accidental self injection may lead to an inflammatory response. If possible the application of gentle squeezing pressure with absorbent material (e.g. facial tissues) at the injection site will swab up unabsorbed liquid. Strong squeezing of the site should be avoided. The damaged area should be thoroughly cleansed and a topical antiseptic applied. Check your tetanus immunisation status.
